

## COMMUNIQUÉ

### REGISTRATION OF DEALERS / MILLERS - 2019

In accordance with **Section 16** of **Part IV** of the **MAURITIUS AGRICULTURAL MARKETING ACT 1963**, the **AGRICULTURAL MARKETING BOARD (AMB)** is inviting prospective dealers / millers of agricultural produce under its control to register themselves for the year 2019. Registration will take place at the **AGRICULTURAL MARKETING BOARD (AMB), Trade and Marketing Department, Moka** at latest by **Friday 29<sup>th</sup> March 2019**, on working days between **09:30 hours** and **15:00 hours**. Application forms are available at the AMB, Moka during office hours or can be downloaded at **www.ambmauritius.mu**.

1) Controlled Products for which registration is required are:

- ONIONS
- POTATOES
- GARLIC

AMB will also carry out registration for the following non-controlled products:

- SPICES – TURMERIC AND CARDAMOMS
- GLASS JARS AND CAPS
- LONG TOM BEANS (*Seed*)
- POLYMESH BAGS
- WHOLE PEELED CANNED TOMATOES
- GINGER

#### *Documents to be produced by Applicants:*

- (i) A **valid trading license** in foodstuffs for the **year 2019** indicating their place of business;
- (ii) A **valid Food Handler Certificate** in their name issued by the **Ministry of Health and Quality of Life**;
- (iii) Their **National Identity Card** and **Certificate of Incorporation**, as and where applicable;
- (iv) **TWO recent passport size photographs** of **all** persons designated as representatives of the Applicant;
- (v) List of drivers, helpers and employees (*if any*) working for & on behalf of applicant and who will be authorised to deal with AMB. Their National Identity Card must also be produced;
- (vi) Copy of Registration Certificate of vehicles to be used by the Applicant (*For authorisation to enter into AMB's premises*);
- (vii) **Business Registration Card**.

Companies are also requested to submit a recent duly signed/stamped Certificate of Current Standing issued by the registrar of companies which is not more than three months old.

#### **N.B:**

- 1) **ONLY DEALERS /MILLERS REGISTERED WITH THE AGRICULTURAL MARKETING BOARD (AMB) WILL BE AUTHORISED TO PURCHASE CONTROLLED PRODUCTS AT AMB'S WHOLESALE PRICES AND/OR DEAL IN THOSE CONTROLLED PRODUCTS.**
- 2) **THE AMB RESERVES THE RIGHT TO SUSPEND/REVOKE THE REGISTRATION AND PERMISSION TO ACT AS A DEALER / MILLER WITHOUT RECOURSE TO ANY JUDICIAL OR EXTRA-JUDICIAL PROCESS.**
