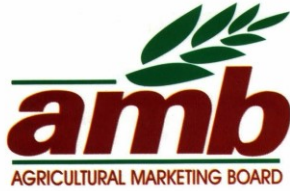

1	Inspection at load port- The inspection of products in relation to the quality, weight and packing shall be carried out by an independent, accredited and internationally recognized inspector/inspection body to be appointed by the supplier. The inspection certificates of quality and quantity to be issued by the inspector prior to loading shall attest that the quality, quantity, weight and packing of the onions in conformity with the contractual specifications. The inspection fees shall be payable by the supplier.	
2	Samples- Supplier will be required to provide samples of products by courier to the Agricultural Marketing Board, Dr. Leclézio Avenue, Moka, Mauritius. The sample shall be in one transparent plastic bag of ½ kg each, bidder's name and address and the country of origin of the products sample. The sample will be analyzed by AMB and other

	relevant authorities and will be used as a bench-mark for all supplies during the above-mentioned period.	
3	Inspection at discharge port- AMB reserves the right to have the products recertified by recognized inspection agencies at delivery point in Mauritius. In case of differences in the quality of the products between test samples taken at load port and discharge port, the quality determined at discharge port shall be deemed final and binding for both parties. The AMB shall bear the survey costs at discharge port.	
4	Claim and contractual dispute- The exporter is not debarred from surveying the consignment at its own cost on arrival Port Louis through an independent surveyor. AMB reserves all right to reject the consignment, should same fail to meet desired quality and agreed terms of shipment. The specifications being the basis for claim are annexed. <u>In the event of any contractual disputes, the court of law in Mauritius shall be used.</u>
