1. <u>Item A – Section V – Schedule of Requirements - Section 3- Technical Specifications: Item A-Section 12 – Pneumatic Shaped solid Tyres with 2 Spare wheel per truck:</u>

The type of tyres should read SOLID tyres.

## 2. <u>Item A- Section 25- 360 Degrees Fork Rotator:</u>
