**RE: DECLARATION OF CONFLICT OF INTERESTS**

Following a Corruption Prevention Review (CPR) conducted by the ICAC, recommendation has been made, amongst others, to the effect that all employees should be made aware of the provisions of Section 13 of PoCA 2002 governing conflict of interests.

You are hereby informed that a conflict of interests involves a conflict between private interests of the public official and the interests of the public body in which he is an employee. The conflict arises when the public official is confronted to a situation where he has a private, direct or indirect, interest in the exercise of his functions.

Any employee, finding himself/herself in any possible situation of conflict of interests, is required to fill in a Conflict of Interests Declaration Form, which may be collected from the Human Resource Section or downloaded from AMB 's website **[www.ambmauritius.mu/publications](http://www.ambmauritius.mu/publications)** and remit same to the General Manager promptly, so as to avoid a corruption offence.
