NOTICE OF VACANCY

The **AGRICULTURAL MARKETING BOARD (AMB)** is a parastatal body operating under the aegis of the Ministry of Agro-Industry, Food Security, Blue Economy and Fisheries and it deals in Controlled Products and related Agri-Business.

With a view to further strengthening its team, applications are invited from suitably qualified candidates to fill the post of **Technical Operator (Shift)** on permanent and pensionable basis.

Qualifications:

A A Cambridge School Certificate or Passes obtained on one certificate at the General Certificate of Education "Ordinary Level" either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject;

B The 'Brevet de Technicien' from a recognised institution in Motor Vehicle Technician's Work or any other related field;

OR

Equivalent qualifications to **A** and **B** above acceptable to the Board.

Salary:

The post carries salary in the scale of Rs 27585 x 320 - 28865 x 350 - 30965 x 400 - 31765 x 425 - 33040 x 560 - 35840 x 725 - 37290 x 925 - 39140 x 970 - 46900 x 1050 - 49000 x 1100 - 51200 a month plus compensation at approved rates.

Duties:

- (1) To maintain and service all handling equipment in general.
- (2) To maintain all plants and equipment in good running condition at all times.
- (3) To overhaul engines, vehicles, refrigeration compressors and cold stores.
- (4) To work on shift whenever required.
- (5) To maintain plant rooms neat and clean at all times.
- (6) To take responsibility of a plant whenever required.
- (7) To keep records.
- (8) To dismantle and re-assemble refrigeration, electrical and mechanical equipment.
- (9) To be able to read refrigeration and electrical circuit diagrams.
- (10) To use ICT in the performance of his duties.
- (11) To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Technical Operator (Shift) in the roles ascribed to him.

Note

Technical Operators (Shift) will be required to work on shift covering a 24 hour service including Saturdays, Sundays and Public Holidays and officially declared cyclone days.

- **Age Limit:** candidates, unless already serving in the public sector, should not have reached their **48th** birthday by the closing date for the submission of applications.
